1. Introduction

Centile has enriched its platform ISTRA™ with a REST API called myRCC. This interface allows platforms owners to connect any Remote Call Control (RCC) application to ISTRA™. The RCC application will be then able to perform call control actions on enabled users of the selected enterprise on ISTRA™.

Microsoft Lync® is one of these RCC applications. Centile has tested it using the myRCC API and declared it certified.

2. Server Configuration

Below are the ISTRA™ configuration steps in order to activate myRCC:

- myRCC is only available on ISTRA™ platforms on version 9.1 or more
- myRCC web service must be enabled on a running Jetty server.

- Login to myRCC is only accessible to administrator that have been granted with RCC authorizations. These administrators should not be real administrator, but created by a platform admin to in order to establish one or several session between two servers.
- When login, an administrator will have to provide the name of the enterprise he wishes to monitor. This enterprise has to belong to his administrative domain, and it cannot be changed during the session.
- Finally, a myRCC parameter should be enabled on each extension to be controlled via RCC.

3. RCC Rest API Catalog

3.1. Services

- **/restletrouter/v1/service/Login** Open and authenticate a session for an enterprise. The cookie + token must be sent set to every subsequent requests . The session is expired after a (configurable) delay of inactivity.
 - Request Header : Authorization: Basic <login|name enterprise:pwd> Base64 encoded.
 - Request Header: X-Application: myRCC
- **/restletrouter/v1/service/Logout** Close session, reset authentication.
- **/restletrouter/v1/service/EventListener/bean** Create / Delete a listener identifier.
 - JSON Request Payload : { “name” : “free string identifier”}

3.2. Extension Resources

- **/restletrouter/v1/rcc/Extension** Fetch the extensions list of the domain available once the user is logged.
 - optional query string : ?offset=int&length=int (permit the paginations list).
- **/restletrouter/v1/rcc/Extension/:id** Retrieve detail of an extension.

3.3. Call control Resources

- **/restletrouter/v1/rcc/Extension/:id/placeCall** Place a call to a given destination
 - JSON Request Payload : { “destination” : “number destination”}.
 - As far a call is created, the call legs states could be asked (pull) by a http request or monitored (push). Call actions are driven by the server which provide in a same representation the state of the call legs and each state the list of possible actions like hold, dtmf ..
- **/restletrouter/v1/rcc/CallLine** Fetch the list of call lines.
 - optional query string : ?listenerName=listener identifier. The listener identifier must be created previously. Adding this parameter to this request starts the monitoring of this resource. The monitoring is disabled since the the identifier is deleted.
- **/restletrouter/v1/rcc/CallLine/:id/:action** Perform an action on a callLine
 - For full list please refers to [Call Lines actions](#)

- Call lines monitoring consists of a series of actions permitting to receive events (push) through a websocket connection previously established. This mechanism permit to be notified of changes of dedicated resource or a list of resources like callines (call legs). In order to avoid flooding clients, the server will send latest full representation of the resources every 100 ms (this duration may change after adjustments) as far the state of the resource has been changed.

3.4. Call Lines actions

3.5. Misc

- Traffic between client and server is done over HTTP protocol, no SSL protection is enabled as far client and server are in a private domain.
- Please note requests may in future versions be redirected permanently/temporarily to an alternative host. In this case the main server will respond by the standard HTTP status code (301 / 302) and provide the response header "Location" the new full URI to address requests.

- Resources are a JSON representation only, XML is not supported. It's recommended to add systematically the mime type to the Accept and Content-Type headers.
- Specific header X-Application : To permit authentication, clients must set the specific header : X-Application: myRCC. Then once client is authenticated, server will responds by the same header + a token. This value must be copied to subsequents requests.

4.Sequences samples

Note : To make sequences more lisble, the headers list is not complete.

4.1. Login / Retrieve extensions list:

1. Log in to enterprise named e1
2. Retrieve the list of extensions.
3. Log out of e1.

4.2. Starts Calls Monitoring

Prerequisite: User must be authenticated.

1. Setup a WebSocket connection.
2. Create a Listener identifier.
3. Start monitoring call lines.
4. Stop monitoring call lines.

4.3. Call Lines management

Prerequisite : User must be authenticated. Monitoring is installed.

1. Place a call from 101 to 102.
2. Receive calls events (101 side only to simplify the reading) through Websockets.
3. 101 holds/unhold the call
4. 101 disconnect the call.
